Terms and Conditions of Facility Rental Agreement

1. Liability Waiver: In signing this Rental Agreement, the undersigned agrees that those using the facilities provided by the Fergus Curling Club, do so at their own risk and that the Fergus Curling Club shall not be liable for any loss or injury.

2. The applicant shall be responsible for any damage incurred to the premises as a result of any act or omission of the Applicant of the Group herein, or any person who attends the function. In the event of such damage, the applicant will be subject to a damage charge, the amount to be determined by the Fergus Curling Club. Tables and chairs are to be returned to their original setting.

3. Alcohol is permitted in the licensed Club Room area only. Alcohol is prohibited in the dressing room, kitchen, and washrooms. It is also prohibited on the ice surface area unless a Special Occasions Permit has been obtained and submitted to the Fergus Curling Club. Alcohol may not be removed from the club and must remain inside the building at all times.
